**Requestor** states that **Requestor** is willing to WAIVE and RELEASE **Crooked Creek Conservation and Gun Club, Inc.** from all claims, demands, causes of action, liabilities, losses, damages, and costs (including but not limited to attorneys' fees) that may arise from injuries or damages ("**Liability**") sustained by Requestor while on the premises and/or participating in **Club Activities**.

**Requestor** AGREES that **Crooked Creek Conservation and Gun Club, Inc.** and its' officers, directors, agents, employees, and affiliates (collectively, "**Crooked Creek**") shall have no liability whatsoever to **Requestor** for any injury or damages, resulting from **Crooked Creek's** negligence, or any other cause, to the **Requestor**, to any property of the **Requestor**, or both while on **Crooked Creeks'** property and/or participating in **Club Activities**.

**Requestor** further agrees that this INDEMNIFICATION AGREEMENT, WAIVER and RELEASE of LIABILITY, applies to, and releases **Crooked Creek** from all liability for all claims, demands, causes of action, liabilities, losses, damages and costs (including but not limited to attorneys' fees) incurred by **Requestor** individually, **Requestor's** spouse, **Requestor's** guest(s), and **Requestor's** heirs, executors, administrators, personal representative and assigns.

**Requestor** hereby RELEASES **Crooked Creek** from all liability that may arise from any and all injuries and damages sustained by **Requestor** while on **Crooked Creek's** property and/or participating in Club Activities, whether caused by **Crooked Creek's** negligence or any other cause.

**Requestor** further agrees to INDEMNIFY and DEFEND Crooked Creek from any and all liability for claims, demands, causes of action, liabilities, losses damages and costs (including but not limited to attorneys' fees) incurred in whole or in part by **Requestor's** negligent, reckless, or intentional acts or omissions.

Requestor has read, understands and voluntarily executes this INDEMNIFICATION AGREEMENT, WAIVER and RELEASE OF LIABILITY, and further agrees that no oral representations, statements or inducement apart from the foregoing written agreement have been made.
