## **MEMBER SAFETY RULES**

- 1. All members must sign in prior to using the facilities and sign out prior to leaving.
- 2. Only members and their guests are permitted to shoot.
- 3. Only shotguns are permitted. (12 gauge maximum) No rifles or pistols.
- 4. Only target shells of 7 ½ maximum and 3 dram maximum are permitted.
- 5. Gun must not be loaded when traveling to/from the fields.
- 6. Gun action must not be closed until shooters are in the field.
- 7. No more than three (3) shells may be loaded at any time.
- 8. Shell retrieving is expected when shooting in the fields.
- 9. Only participants are allowed in the fields.
- 10. Alcoholic beverages are not permitted at any time.
- 11. Eye protection must be worn by shooters at all times.
- 12. No one is allowed to use the property without signing the Indemnification Agreement, Waiver and Release of Liability.
- 13. Shooting Preserve Rules and Miscellaneous:
  - a. No hunting wild birds.
  - b. No hunting birds left by others.
  - c. ATV's must stay on mowed paths.
  - d. Maximum shot size is 7 1/2.
  - e. Clean up after yourself.

- f. Only one (1) field may be used at a time. You cannot tie up the entire club at one time.
- g. Take harvested birds with you. Do not clean harvested birds on the property. Cleaning harvested birds at the club ruins the scent for other dogs.

As a condition of my membership, if physically able, I agree to donate two (2) days of work time to assist in maintaining the grounds and buildings.

I agree to abide by the safety rules of Crooked Creek Conservation and Gun Club, Inc. I further agree to assume full responsibility for my own actions and omissions and agree to indemnify and hold harmless Crooked Creek Conservation and Gun Club, Inc., and its officers and directors from and against any and all liability including attorney's fees in connection to my actions and omissions while on the property of Crooked Creek Conservation and Gun Club, Inc.
